**Note:** For Council to repurchase unused burial plots, it will be calculated at 50% of current value or original purchase price whichever is greater. Plots can only be sold back to Council in accordance with the Cemeteries and Crematoria Act 2013 No 105 Cemetery Offences relating to conduct in cemeteries Section 70 Cemeteries and Crematoria Act 2013 No 105

A person must not, without lawful authority, in a cemetery:

- disturb or interrupt any service, procession or cortege or
  - inter any human remains or scatter/inter ashes without permission from the grave owner and Council.
- All cemetery fees stated below are charged for Monday to Friday between the hours of 9.30am and 3.30pm. Other times are by arrangement.
  - \*After 3.30pm, a late fee of \$368 per hour (incl GST) will apply.
  - For weekends and public holidays, a surcharge of \$322 in addition to the interment fee.
