Approval from Council may only be granted for the burning of dead and dry vegetation on premises which the vegetation grew. No other material may be burnt. Approval may be granted at the discretion of the assessment staff.

It is an offence to burn material not in accordance with an approval. The maximum penalty is \$5,500 for an individual and \$11,000 for a corporation.
