To be exempt from Council Rates:-

- The organisation must own and occupy the property and the property must be used for the purposes of the organisation as stipulated in their articles of association or like documentation.
- The use of the land that is to be exempt from rates, must be listed as per Sections 555 or 556 of the Local Government Act.

EXAMPLE of Properties that may be exempt from rates are Churches, hospitals, Schools or Public Charities.
